

## **SETAPAK CENTRAL: MERDEKA DRAWING CONTEST 2025**

## **FULL TERMS & CONDITIONS [CONTEST]**

- 1. This contest is organized by Festiva Mall Sdn. Bhd (FMSB), the owner of the shopping mall now known as "Setapak Central" (SC).
- 2. This contest will be held on <u>31 August 2025 (Sunday)</u>, <u>2pm.</u> Participant registration is open now until 24 August 2025, or until all slots are filled whichever comes first.
- 3. This contest is open to all shopper, aged 7 to 12 years old ONLY at the time of entry, EXCEPT:
  - (a) an FMSB or related company employee, contest organizers or contractor involved in the Contest, or
  - (b) the spouse, partner or immediate family member of an FMSB employee, contest organizers or contractor involved in the contest, is **NOT** eligible to enter the contest, or
  - (c) the retail staff in Setapak Central is **NOT** eligible to enter the contest.

- 6. A parent or guardian must accompany the child throughout the duration of the event. The organiser is not responsible for the care or supervision of participants.
